#### Respected Your Lordship's

This is Mr. Vinod H Wagh, an Assistant Professor in VPM's TMC Law College, Thane, Maharashtra. I am writing this letter to bring kind attention of Your Lordship's towards the clampdown of many journalists throughout India at one hand and the aggressive and anti-social journalism at other. This letter is also a kind request/prayer to this *Temple of Justice* to frame certain guidelines thereby Press remain a *Neutral Pillar of Democracy* and free from fear and favour. The Journalists must feel safe for what they are expressing and must not be subjected to the jail for their reporting.

This Court has great history. Every Indian bow before this Court for every verdict that upholds the *Equality, Freedom, Life and personal Liberty guaranteed under our Constitution*. 23 years ago this Hon'ble Court initiated the Public Interest Litigation on the basis of simple letter. The guidelines came out from that PIL controlled an arbitrary power of the State. *D K Basu vs. State of West Bengal (1997 AIR SCW 233)* was this courts credit. Till today *D K Basu* case is part of Law Syllabus. The Nation again looking forward to this Court and praying with folded hand to frame some protective guideline for the journalism and make sure that they should not be subjected to State's ire.

I am referring certain case study here to make this Hon'ble Court realised about the injustices happened to the journalists throughout the nation. The suppression of journalists and journalism will destroy the very fabric of our Democracy. This Hon'ble Court must come to the rescue of such suppression of free journalism. At the same time this Hon'ble Court also need to look into the communal and fake journalism which is threat to our Democracy. Controlling such journalism is also necessary to long live our Democracy.

The following instances happened throughout India shows that how States are using their power against the journalists for their reporting, especially not suitable to State. The State not named here does not mean there are no instances of this nature in that State. Whatever was possible for me is laid down here.

I would like to also bring your Lordship's attention towards another fact. The above journalist have done their job and reported against the State/administration and booked under different penal laws and arrested. Some of them are on bail and some are still in jail. The appropriate judicial forum will decide their wrong. I have no comment to make on it. But at the same time the Law and Order machinery not utter a word against other side of journalism and journalist, who openly abused the community, scandalise the reputation of individuals, make allegations without evidences, debating in very immoral way and aired fake news. Kindly see the following instances. Still No state Government or any other agency Suo-moto register any FIR against any of them.

Your Lordship, the above both tables (taken only for instances with no specific complaints) and instances are not healthy for Democracy. At one hand we see, immediate and strict action for the news reported on mal-administration and fair/unfair criticism. Other side no action even for fake and communal reporting and debates. These both approaches should not be welcomed.

This letter, therefore humbly prays this court to issues certain guidelines whereby the journalists must feel safe for true journalism and must have a fear for fake and communal journalism. The self-restrictions of press seem to be not working.

A complaint against journalists for what he has done as journalist is one thing and complaint against a person who is happened to be journalist is other thing. Well known journalist Mr. Arnav Gouswami's example is very much relevant here. Many FIR were registered against him when he had reported on Palghar lynching case. That was for what he had done as journalist. Another FIR was lodged against him by private individual for the offence under Section 306 of IPC was different one. The guidelines may address such issues too.

Your Lordship, the Press and Media is backbone of every Democracy and therefore protection of the press and journalists is very much necessary. Hence I request you to kindly frame certain guideline to protect the journalism and journalists from arbitrary action of the State. This Hon'ble Supreme Court laid down the procedure in case of

Arnesh Kumar vs State of Bihar (2014) 8 SCC 273 about no automatic arrest. Such things may be applied/done to the journalist. Any reporting against the State Government or their administrative departments or any criticism on the State affairs may not call for any coercive action against the journalist. At the same time communal and fake news may be controlled through following a legal way.

This Hon'ble Supreme Court has always come to the rescue of the *Democracy*, *Secularism*, *Freedom*, *life and Personal liberty of an Individual*. In the absence of any legislation this Court has made laws and gave it to the nation.

When Criminal Procedure Code was lacking fair arrest procedure, this Court has given guidelines in *D K Basu vs State of West Bengal 1997 AIR SCW 233*.

When women of this country were unsafe on workplace this Court has given guidelines in *Vishakha vs State of Rajasthan AIR 1997 SC 3011* 

When section 498-A of the Indian Penal Code was started misusing and unnecessary arrest of accused, this Court has given guidelines in *Arnesh Kumar vs State of Bihar* (2014) 8 SCC 273 and protected accused from unnecessary arrests.

This Court has given guidelines about mandatory registration of FIR in case of *Lalita Kumari vs State of Uttar Pradesh (2014) 2 SCC 1* 

This Court has issued guidelines to stop the fake encounter in case of *PUCL vs State of Maharashtra CDJ 2014 SC 831*.

Therefore, it's humble prayer to this Hon'ble Supreme Court that in order to protect the *DEMOCRACY*, *Personal Liberty and Professional Liberty* of journalists and journalism, this Hon'ble Court may frame some guidelines and protect the spirit and principles of our great Constitution.
